HLTAID001 – Provide Cardiopulmonary Resuscitation

This course equips participants with the skills and knowledge:

- to recognise when someone is in sudden cardiac arrest i.e. unresponsive and not breathing or not breathing normally
- to increase casualty's chance of survival by calling for emergency services and performing potentially lifesaving cardiopulmonary resuscitation (CPR) including application of a defibrillator (if available) until emergency services arrive and take over.

The unit of competency incorporates training in the skills and knowledge required to perform cardiopulmonary resuscitation (CPR) in line with the Australian Resuscitation Council (ARC) Guidelines

The unit also requires participants to attain competency in the application of an automated external defibrillator (AED) to a casualty who has suffered a sudden cardiac arrest.

The unit is available to all persons who wish to attain competency in the provision of CPR and is applicable for all workers who may be required to provide CPR, in a range of situations, including community and workplace settings.
